FREQUENTLY ASKED QUESTIONS

1. Can I also re-earn the \$50 Consultant bonuses during the Crystal Reset?

No, Crystal Reset does not impact the Consultant or Consultant Development Bonuses (which are part of our Rank Advancement Bonuses program).

2. On Feb. 20, 2017 my Recognition (highest achieved) rank was Director. What can I earn during this promotion?

During this Crystal Reset promotion, you are eligible to re-qualify for Crystal Manager, Crystal Director and achieve Crystal Executive.

3. If I achieve Crystal Executive in the Crystal Reset, do I qualify for the Crystal Executive League?

Yes, anyone who reaches Crystal Executive during the Crystal Reset (even those who have previously reached Executive) will qualify for the Crystal Executive League for Celebration 2017. Learn more about the Crystal Executive League at IsaFYI.com/Recognition.

4. When are the Crystal Reset awards paid out?

All Crystal bonuses are paid four weeks in arrears (Five Weeks in arrears for Indonesia). For example, if you achieve Crystal Director on May 10, 2017, your bonus would be paid on June 12, 2017.

TO QUALIFY FOR NEXT HIGHER CRYSTAL RECOGNITION RANK

1. I have personally enrolled team members who were Consultants but went inactive. If I help reactivate them and they reach Consultant again, will they count toward my next Crystal Reset award?

Yes, as long as they have joined and remain Active in your organization.

2. On Feb. 20, 2017 my Recognition (highest achieved) rank was Consultant with one Active personally developed Consultant. How do I achieve Crystal Manager, and what do I earn?

Create one more personally developed Consultant or reactivate your existing Consultant, and make sure you have two Active Consultants at the same time before April 25, 2017. You'll earn a US\$250 bonus, a recognition pin and certificate.

3. To earn the Crystal Executive bonus do I need to have five Active Consultants on each leg?

Yes, if this is your **first time** achieving Executive Recognition Rank, you must have five Active Consultants on your left leg and on your right leg in order to be Paid-As Executive, earning the Matching Team Bonus and earning the Crystal Executive reset bonus.

TO REQUALIFY FOR CRYSTAL RECOGNITION RANK

1. On Feb. 20, 2017 my Recognition (highest achieved) rank was Executive. Can I reactivate Consultants to earn Crystal Reset bonuses?

No, you must create Consultants from NEW personally developed team members OR from personally developed team members who are Preferred Customers and become Associates OR from personally developed team members with a Recognition rank of Associate.

2. On Feb. 20, 2017 my Recognition (highest achieved) rank was Executive. What can I earn?

All Associates who have previously reached Executive can re-earn the Crystal Manager, Crystal Director, and Crystal Executive bonuses. However, Executives participating in the Crystal Reset cannot reactivate Consultants to earn the bonuses.

3. On Feb. 20, 2017 my Recognition (highest achieved) rank was Manager. If I advance to Crystal Executive during the reset period, am I eligible to earn the Crystal Manager, Crystal Director, and Crystal Executive bonuses?

Yes, you are eligible to requalify for the Crystal Manager, and achieve Crystal Director and Crystal Executive bonuses before the deadline of each Crystal rank, if you create **NEW** consultants based on the required criteria (Crystal Manager - Total of 2 NEW Consultants; Crystal Director - Total of 6 Consultants; Crystal Executive - Total of 10 Consultants). You can reactivate your existing consultants to achieve your next higher Crystal Recognition Rank - Crystal Director and Crystal Executive.

4. On Feb 20, 2017 my Recognition (highest achieved) rank was Director. If I personally develop 2 NEW Active Consultants, can I earn the Crystal Manager bonus?

Yes, you are eligible to qualify for the Crystal Manager bonus of US\$250.

5. On Feb. 20, 2017 my Recognition (highest achieved) rank was Executive. Do I have to have five Consultants on each leg to achieve Crystal Executive?

No, you can place your Consultants anywhere as long as you **personally develop 10 new Consultants** before August 30, 2017, you can achieve Crystal Executive bonus. However, to be Paid-As Executive and earning the Matching Team Bonus, you still need to have five Active Consultants on each leg.
