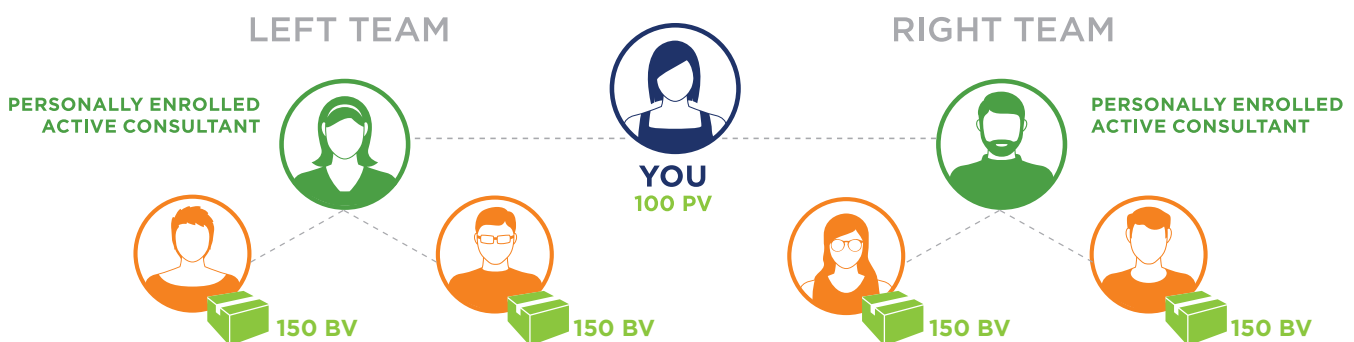

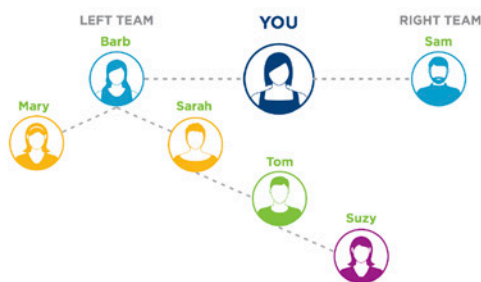
How do I register?

Opt-In via the Back Office under the 'Contests & Promotions' tab and select 'Chase the Sun Challenge'. Registration is from Monday 10 September, 2018 12:01am (US EST) to Sunday 18 November, 2018 11:59pm (US EST).

Do previous enrolments made by my current 4PET count towards my qualification?



No. Only the BV from new Customers enrolled from 10 September 2018 to 16 December 2018 (US EST) in your 4PET will count towards the Chase the Sun Challenge.

When can I get started building my 4PET and accruing BV?

BV for your new 4PET accrues from Monday 10 September, 2018 12:01am (US EST) until Sunday 16 December, 2018 11:59pm (US EST). BV accrues cumulatively during the contest period. To qualify, new enrolments must:

- Be a new Preferred Customer or Associate to Isagenix
- Be 18 years or over
- Be a citizen or tax-paying resident of their home market
- Have paid their own membership fee on the Isagenix website
- Have met all other enrolment criteria in the Policies and Procedures

How can I keep track of my 4PET BV?

BV generated by your 4PET will be conveniently displayed in your Chase the Sun Challenge individual report in your Back Office. You can view the report by visiting 'Contests & Promotions' or the 'Reports' section under 'Business'.

How do I earn my free products for opting in?

Register in your Back Office between Monday 10 September and Sunday 23 September and you'll earn yourself a free box of e-Shots and IsaLean Bars. To collect your free goodies, product coupons will be loaded in your Back Office on Friday 28 September for you to use with your next order.

How do product returns affect my BV total?

Any product returns will be deducted from your overall BV total after a return order is received by our returns warehouse and processed at the Isagenix Corporate Office.

What if one of my 4PET members is in an international market?

International enrolments that are adequately validated in their home market can be members of your 4PET. Please note, you will need an International Sponsorship for you to accumulate international BV. Can I bring a guest?

Great news, we've added new levels to this competition! If you earn either Level 1 or 2 prizes, we'll pay for your guest to come with you.
