Now, add up all your 1PET personal Enrolment Points, 2PET Enrolment Points, and Personally Enrolled Rank Advancement Points for the entire month.

Next, add in any points earned from Active Executive rank weeks only (4 points per week).

Let's say you earned 40 total points, so you earn 40 shares

At the end of the month we add up everyone's total shares earned. In this example, there were 6,000 total shares earned. To determine the share value, do the following:

US \$150,000 / 6,000 = US \$25

You earned 40 shares,
so 40 x US \$25 = US \$1,000, so you

would earn a US \$1,000 bonus.

That's it!

WHAT YOU NEED TO KNOW

- 1. The pool is open to Isagenix Independent Associates in Europe, United States, Puerto Rico, Canada, Australia and New Zealand.
- 2. Associates can participate in the Executive to 3-Star Golden Circle Pool for up to six months from 28 June 26 December 2021
