FAQS

HOW DO I REGISTER?

Opt-In via the Back Office under the 'Contests & Promotions' tab and select 'IsaRally Paris'.
Registration is from Monday 11 February 2019 12:01am (US EST) to Sunday 14 April 2019 11:59pm (US EST).

DO PREVIOUS ENROLMENTS MADE BY MY CURRENT 4 PET COUNT TOWARDS MY QUALIFICATION?

No. Only the BV from new Customers enrolled from Monday 11 February 2019 12:01am (US EST) to Sunday 12 May 2019 11:59pm (US EST) in your 4 PET will count towards the IsaRally Paris Challenge.

WHEN CAN I GET STARTED BUILDING MY 4 PET AND ACCRUING BV?

BV for your new 4 PET accrues from Monday 11 February 2019 12:01am (US EST) to Sunday 12 May 2019 11:59pm (US EST). BV accrues cumulatively during the contest period.

To qualify, new enrolments must:

- Be a new Preferred Customer or Associate to Isagenix
- Be 18 years or over
- Be a citizen or tax-paying resident of their home market
- Have paid their own membership fee on the Isagenix website
- Have met all other enrolment criteria in the Policies and Procedures

You must enrol 10 new Customers or more with a minimum initial order of 150 BV during the competition period.

CAN I BRING A GUEST?
