Isagenix Policy Regarding Termination and Time Frames for Re-Enrolling

As an independent contractor, you may maintain or terminate your position as you deem fit; however, Isagenix does not permit a Position Holder to re-enrol in or take an ownership interest in another Position with Isagenix after terminating their Position in Isagenix unless the Position Holder meets certain conditions:

- Customers may reapply six months from the date of their most recent Qualifying Activity.
- Associates who have never earned a commission or who have earned less than \$500 USD total from Isagenix over the 12-month period immediately preceding their last Qualifying Activity may reapply six months after the date of their last Qualifying Activity.
- Associates who have earned Compensation totaling \$500 USD or more with Isagenix over the 12-month period immediately preceding their last Qualifying Activity may reapply 12 months from the date of their last Qualifying Activity.
- Regardless of income received, Associates who have ever achieved the rank of Director or above may reapply 24 months from the date of their last Qualifying Activity, and neither they nor their spouse are eligible to re-earn any Rank Advancement Bonuses previously earned in either of their Positions.

We permit spouses to hold separate Positions, so long as they are in the same line of sponsorship. A Position Holder whose spouse holds a separate Position may not terminate their current Position and re-enrol in another Position unless their spouse also meets the conditions applicable to their respective rank. If you wish to re-enrol, your spouse will also need to complete and submit this form to complianceANZ@isagenixcorp.com

If you wish to continue ordering Isagenix products at discounted Member prices during your waiting period without resetting your waiting period each time you order. You can do so in your Back Office or by contacting Customer Service. Volume from your purchases will continue to be credited to your current Enrolling Sponsor, until the waiting out period has been observed.
